PRIVATE CHARTER

Please note that Private Charter bookings are made with third party suppliers and can be subject to cancellation or change.

LODGE FACILITIES AND ACTIVITIES

CANCELLATION POLICY

Once a reservation is confirmed, the guest is liable for any cancellation fees.
Confirmed reservation cancelled:

- 60+ days before arrival full deposit forfeited
- Between 30 & 60 days before arrival –
 50% of full cost payable
- Less than 30 days before arrival 100% of full cost payable
- **All guests must have valid medical and travel insurance which will enable them to be evacuated should the need arise. Vamizi Island has a medical evacuation scheme coordinated and managed by Africa Assist. The evacuation is borne by the insurance company, for which Vamizi pay a premium per guest per night. During the process or after the patient is in a medical facility, Africa Assist will place the guest's medical insurer on notice that a claim is in process.**
